

PLEASE READ CAREFULLY
AGREEMENT TO WAIVE VALUABLE LEGAL RIGHTS:
ICE STATION VALENCIA, LLC, & AFFILIATED BUSINESSES
(hereafter referred to as Ice Station)

In consideration of receiving permission from **ICE STATION** to ice skate, play ice hockey or otherwise use the rink facilities, in addition to the admission charge, which I have paid, I hereby expressly agree:

- 1.) to **ASSUME ALL RISK AND RESPONSIBILITY**, for any injuries I may sustain, any injuries I may cause to any other person, and any damage I may cause to **ICE STATION** or to my property or to the property of any other person in connection with my activities at **ICE STATION** (including, without limitation, injuries or property damage caused by any equipment I may rent from **ICE STATION**).
- 2.) to **RELEASE** the **ICE STATION** and its directors, officers, instructors and employees, and its landlord, **FROM ALL CLAIMS AND LIABILITY** for any injuries I may sustain or any damage that may be caused to my property in connection with my activities at **ICE STATION** (including, without limitation, injuries or property damage caused by any equipment I may rent from **ICE STATION**), even if my injuries or the damage to my property is caused, in whole or in part, by negligence or fault of the **ICE STATION**, its directors, officers, instructors or employees or its landlord.
- 3.) to submit any dispute that may arise between me and the **ICE STATION** and/or its directors, officers, instructors and/or employees in connection with my activities at **ICE STATION** to **BINDING ARBITRATION** before three arbitrators in accordance with the rules of the American Arbitration Association.
- 4.) that if I submit any dispute I may have against the **ICE STATION** and /or its directors, officers, instructors or employees, relating in any way to my activities at **ICE STATION** to binding arbitration, and the arbitration panel resolves the dispute against me, or if the award I receive in such arbitration is less than the amount which **ICE STATION** had previously offered in settlement of my claim, I will **REIMBURSE** the **ICE STATION** and /or its directors, officers, instructors or employees, relating to my activities at **ICE STATION**, and a court or other tribunal resolves the action against me, or if I should receive judgment in such legal action which is less than the amount which **ICE STATION** had previously offered in settlement of my claim, I will also reimburse the **ICE STATION** and/or its directors, officers, instructors or employees, for all costs and expenses (including legal fees) they may incur.
